**Approval of Minutes**

***MOTION:** Susan moved to approve the April 2022 minutes. The motion was seconded by Rebecca, all in favor.*

**President's Report**

Marcy and Susan testified at the subcommittee re-districting meeting. The DC Federation of Civic Associations is having its 100<sup>th</sup> Anniversary this year. DCCA sent a congratulatory letter to them and there is a luncheon to celebrate the org on June 18<sup>th</sup> at 11:00 a.m. – Marcy and Susan plan to attend on behalf of DCCA.

**Treasurer's Report**

Lance sent the Treasurer's report in advance of the meeting and briefed everyone on spending including operating costs, gardening supplies, water support payment and partial payment for the irrigation system.

**ABRA**

**Rosemarino D'Italia** –Glenn summarized the latest developments: the operator withdrew request for an amended license, and that motion was opposed by the group protesting (a mix of residents and DCCA). ABRA agreed with the withdrawal. The license will come up for renewal in October, the long list of noise and conduct concerns remain and will need to be addressed at renewal.

Additionally, the group protesting has had conversations/concerns that the establishment is working with other taverns in the area to develop an entertainment district on this northern section of Connecticut Ave. a high-level concern to DCCA because unlike club central this is outside the business district and abuts residential area.

***MOTION** Rebecca moves to consider offering financial support to the protest group, of which DCCA is a party, in direct contribution to its legal bills, up to \$3,000. Susan seconds the motion. All in favor.*

**Parks and Gardens Updates:** Rebecca let the board know she expects a right to entry approval on June 27<sup>th</sup> at which time the remainder of the irrigation bill system will be due after that. Rebecca is also staying on top of the Adopt-A-Park proposal and future signage. Rebecca also updated new board members on the overall garden work and investment in the T Street and Freedom park.

***MOTION: Susan moves to authorize Lance to move up to \$5,100 from Fidelity to TD so that funds are available for upcoming reimbursements, Parade, irrigation and other needs. Rebecca seconds the motion. All in favor.***
